Product Information

BioEnhancer is an insect feeding stimulant. When combined with chemical and/or biological insecticides it may increase their efficiency. BioEnhancer stimulates insects of the Lepidoptera Order to eat insecticides thereby increasing the effectiveness of insecticides.

BioEnhancer can be tank-mixed with biological insecticides such as Bt (*Bacillus thuringiensis*) and chemical insecticides such as carbaryl, chlorprifos, methyl parathion, parathion, pyrethroids, etc. BioEnhancer is effective on earworm, cotton bollworm, cutworms, diamond back moth, loopers, sod webworms, tobacco budworms, and tomato fruitworm. It can also be used on any crop for which the companion insecticide is registered for use.

DIRECTION FOR USE

Add 16 oz. of BioEnhancer per acre in the same tank as the recommended amount of pesticides. Follow instructions for each pesticide in accordance with their label.

With agitation add BioEnhancer to the spray solution and then add the insecticides. Provide sufficient agitation during application. Use 60 mesh or larger screens or slotted strainers in spray system and 40 mesh screen behind nozzles.

STORAGE

Reclose containers of unused BioEnhancer. Store in a cool dry place out of sunlight and away from children.
