APPLICATION RATE TABLE

Mix 1 gallon of GC-Mite concentrate per 100 gallons of spray water. Apply enough to cover the entire surface of infested tissues.

Apply no more than once in a 7 day period. Repeat application as necessary. Coverage is essential to establish control. The use of a spreader/sticker such as JH Biotech's *Natural Wet*[®] may increase contact and efficacy of treatment.
